## **Frequently Asked Questions**

## 1. What was the deadline to complete the requirements for the Health Premium Credit Program?

April 30<sup>th</sup>, 2024 at 11:59pm EST.

#### 2. What were the requirements for the 2024 Health Premium Credit Program?

- 1.) Log on to WellStarME and
- 2.) Complete the Wellness Questionnaire on WellStarME and
- 3.) Watch the Primary Care Provider Resources video **and** take a short quiz on WellStarME (the first question will appear once the video has ended) **and**
- 4.) Complete **one** of the following "My Health" options:
  - Get your numbers from a free-standing lab (Please Note: your primary care provider must send a lab order to your preferred lab.) OR get your numbers from your primary care provider
  - OR Receive a Flu Shot
  - OR Have a "Well-Being" visit
  - OR Have an Annual Physical Exam (New this year!)
  - OR Participate in a Health Navigation appointment

"My Health" option may be completed between May 1st, 2023 and April 30th, 2024 at 11:59 PM.

### 3. What is the premium cost for the health insurance?

### 4. I have filed an appeal; when will I hear a decision on my appeal?

Each appeal will be reviewed by Employee Health & Wellness as soon as administratively feasible after the appeal deadline (August 9<sup>th</sup>, 2024). The information will be compiled for the State Employee Health Commission who will meet to review appeals and render a decision. You will then be notified in writing of their decision.
