**PRINCIPAL REASON(S) OR PURPOSE FOR PROPOSING THIS RULE:** The proposed rule would update Section 8(I) Support Service Limits – Mileage Reimbursement to be consistent with the rate afforded to those covered under the Maine Service Employees Association (MSEA) contract. The proposed rule change would refer readers to the State of Maine rate found on the DHHS, Department of Administrative and Financial Services, Office of State Controller at <a href="https://www.maine.gov/osc/travel/mileage-other-info">https://www.maine.gov/osc/travel/mileage-other-info</a>. In addition, the proposed rule would add DHHS, Divisions of Contract Management and Audit requirements for distribution of gift cards when

The proposed rule change would be effective retroactive to January 1, 2024. Retroactive rulemaking is permissible under 22 M.R.S. § 42(8) as this update provides a benefit to SNAP E&T recipients or beneficiaries and does not adversely impact applicants, participants, beneficiaries, or providers.

**ANALYSIS AND EXPECTED OPERATION OF THE RULE:** The proposed rule change aligns Support Service Limits – Mileage Reimbursement with the MSEA rate.
