


Stainless Steel Scallop Grader



HURRICANE ISLAND MAST + BOOM SCHEMATIC 500# WARKING LOAD





1. How does adding this gear change your existing operations?

This gear does not change the level or type of activities on-site. Work cleaning and restocking gear already occurs and will not significantly increase in volume or duration. The proposed equipment allows farm workers to access farm gear and organisms more safely and efficiently.

The addition of a power washer will allow regular, more effective, and physically easier gear cleaning due to decreased labor demand. It will be used 5 days a month from May-October for no longer than 5 hours a day.

A scallop grader will make our restocking of lantern nets and cages into appropriate densities more efficient, resulting in less time out-of-water for our scallops. The addition of a mast and boom permits safe movement of gear from our boat to the float, reducing the physical lifting needed.

The mast and boom and the scallop grader are powered by 12 and 24v DC electricity, produced by a small solar array and battery bank. Therefore, there are no changes to the level of noise on the farm. The tasks performed by this equipment (moving gear and sorting scallops) are already performed by hand, so there will be no change to the level of on site activity.

The gasoline power washer will very occasionally increase the noise level at the site. Cleaning gear, which the power washer will be used for, does not occur more than once a month. It will be used 5 days a month from May-October for no longer than 5 hours a day. The cleaning that would be done by the power washer is already performed by hand, so there will be no change to the level of on site activity.


